## **VISITOR CODE OF CONDUCT**

- 4. Running, horseplay, skating, rollerblading, skateboarding, or any action that interferes with the free flow of traffic in the building and/or access to businesses. Bicycles and Segways must be used in accordance with bicycle and vehicle safety rules.
- 5. Standing or walking in such a way as to cause inconvenience to others.
- 6. Littering, throwing, discarding, or depositing any paper, glass, or other matter of any kind anywhere except in designated trash receptacles.
- 7. Defacing, damaging, or destroying any real or personal property that is part of, or located in or on, the building, including writing, spraying, scratching, or otherwise affixing graffiti on such property.
- 8. Yelling, screaming, playing loud music, or similar behavior that creates noise of sufficient volume to interfere with the hearing or peace of the general public or building patrons.
- 9. Assembling, demonstrating, protesting, petitioning, parading, picketing, marching, walking abreast in groups and/or loitering for the purpose of disturbing the peace or any unlawful purpose, disrupting the enjoyment of customers/guests, or disrupting the intended business use of the property. No solicitations for charity without prior written permission of management.

- 10. Distributing commercial advertising of any kind, offering samples of items that are sold or available for sale, or actually selling products or conducting surveys.
- 11. Bringing animals on property with the exception of animals owned and permitted by condominium owners of the building, animals in the company of persons trained to assist physically challenged patrons, those animals going to or from pet stores or photography studios (if any) or involved in property sponsored events.
- 12. Wearing no shirt or footwear.
- 13. Sitting on stairs, planters, or trash receptacles or any improper use of property amenities.
- 14. Consuming alcohol anywhere within the common areas.
- 15. Being intoxicated and/or possessing or being under the influence of illegal drugs.
- 16. Possessing an explosive or incendiary device of any kind (including fireworks).
- 17. Entering any area of the property not open to the public.
- 18. Violating any federal, state, or local laws, rules or ordinance.
- 19. Smoking. This building is a smoke-free environment. Smoking is permitted only in designated areas.
- 20. Unauthorized use of private parking facilities. Parking violators may be subject to towing at the vehicle owner's expense.
